MINUTES OF THE MEETING OF SPIXWORTH PARISH COUNCIL HELD AT 7:30 pm ON TUESDAY 3rd MARCH 2020 AT SPIXWORTH VILLAGE HALL ROOM 89

There were 3 members of public in attendance.

Reports and Parishioner's Question Time

A member of the public attended the meeting to ask the following questions:

- Concern was raised about North Walsham Road junction from Crostwick Lane what was being done about it. Councillor Roper responded that the original plan was to install a roundabout at this location, but it was turned down by NCC for cost reasons. Rackheath Lane was closed off instead. Several residents have requested to set up a petition to have traffic lights installed at the junction with the support of Councillor Roper.
- 2. A question raised regarding expenditure of CIL money. Councillor Rowe responded with a brief outline on what this money is used for, with an input from Councillor S Vincent.
- 3. A question was raised regarding the state of the tennis court located on the village hall playing field grounds. Councillor Rowe responded and explained that this matter needs to be discussed at a trustee meeting as the court does not belong to the parish council.
- 4. A question was raised regarding why the allotments were still not ready. Councillor Rowe responded and explained that the developer still owns the allotments and the Trustee of the village hall are waiting for a legal document from Broadland District Council. The allotments must be in a satisfactory state before the Trust will take them on. Currently they are overgrown with weeds which the developer is refusing to cut back.

Councillor D Roper reported the following:

Norfolk County Council: NCC budget information was provided at last months meeting, the council are trying to get a bit more commercial. There was also a review of funding for bus services

Broadland District Council: BDC held their budget meeting, council tax increase of 3.61%. From April 2020 District Councillors will be allocated a grant of £500 to spend towards projects in their community area.

Councillor Roper left the meeting.

9. AMENITY MATTERS

9.1 The council discussed the removal of padlocks from the gates leading onto Greg's Meadow due to a few requests received from parishioners wanting a set of keys to have access through the main gate for disability reasons. The council decided to keep the gates locked for safety reasons. The council have requested that the clerk set up a deposit system so that going forward there will be a cost to have spare keys cut.

9.2 The council discussed where we are with the legal transfer of the amenity land located on Crostwick Lane. The parish council's solicitor has advised that the land needs to be valued before it can be transferred to the ownership of the parish council, Hopkins Homes can provide this valuation for them for land registry purposes. The parish council and their solicitors have requested a copy of the section 38 agreement from Hopkins Homes which relates to soakaways on the land. Hopkins Homes are asking the parish to be party to this agreement but have not

provided the parish council with a copy. Hopkins Homes also need to provide a map detailing where utilities and soakaways are located.

9.3 Councillor Rowe had a walk round Spixworth to note the location and amount of dog and litter bins that there is currently. It was reported back that a litter bin is needed at the Arthurton Road bus stop and maybe a couple more dog bins towards the end of Quaker Lane and on the NDR route into Old Catton.

9.4 It was noted that a new photocell has been fitted to the light columns on Greg's Meadow for the lights to turn on when required.

10. HIGHWAY MATTERS

10.1 The clerk provided copies of the latest SAM 2 data.

10.2 The council agreed to accept Garden Guardian grass cutting quote for 2020/21 as it was the cheapest option. Due to the subsidy amount that Norfolk County Council Pay the parish council to cut highway grass the number of cuts needed to be reduced it was agreed that Garden Guardian would reduce their cuts to 11 per year for Highway areas.

12. NEIGHBOURHOOD PLAN

12.1 Councillor S Vincent reported that examination for the neighbourhood plan starts on 2nd March 2020. The examiner will carry out an unescorted visit around the village to make notes. A draft report will be produced with possible further questions to be answered.
